



SUNSET Photo CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. The Original Oyster House is seeking the best sunset photos taken at either the Gulf Shores location or the Spanish Fort location. The owners of the TWO best photos will receive dinner for two (\$50 value) at the Original Oyster House. Two runners-up will receive Original Oyster House tote bags filled with prizes. The promotion shall be subject to these Official Rules, and by entering, all participants agree to be bound by terms and conditions herein.

Eligibility: Sunset Photo Contest is open only to legal US residents who are at least eighteen (18) years of age as of November 1, 2017. Sharing your sunset photo on Facebook.com/OriginalOysterHouse using the official hashtag, #OOHSunset, denotes your certification that you are 18 years of age or older.
